


Rural Community Health Centers

Community Health Centers are nonprofit safety net providers in rural areas providing high-quality, affordable primary care, which includes oral health, mental health, substance use, and enabling services such as transportation or translation services.



- Offer an income-based sliding fee schedule regardless of patients ability to pay.
- Employ interdisciplinary teams.
- Deliver care coordination and other enabling services that facilitate access to care.
- Are patient-governed, community organizations.

Nationally, there are over 15,550 health center sites:

- Community Health Centers
- Health Care for the Homeless
- Migrant Health Centers
- Primary Care in Public Housing
- School-Based Health Centers

NRHA Supported Legislation

Extension of Federal Funding for Health Centers

Sens. Sanders (I-VT) & Marshall (R-KS); Reps. McMorris Rogers (R-WA) & Pallone (D-NJ) Supports extension of mandatory federal funding for community health centers, through either from the 118th Congress, H.R. 5378 Lower Costs More Transparency Act or S.2840 Bipartisan Primary Care and Health Workforce Act, to ensure high-quality low-cost preventive care in rural areas.





Equal Access to Specialty Care Everywhere (EASE) Act of 2024

(H.R. 7149 in the 118th Congress) Reps. Steel (R-CA) & Lee (D-NV)

Creates a virtual specialty network demonstration that offers integrated services in rural communities to test the effectiveness of increasing access to specialty care and facilitating transitions to value-based payment.

Telehealth Modernization Act

(S. 3967/H.R. 7623 in the 118th Congress)

Sens. Scott (R-SC) & Schatz (D-HI); Reps. Carter (R-GA) & Blunt Rochester (D-DE)

Expands coverage of telehealth services through Medicare and making permanent COVID-19 telehealth flexiblities for community health centers and Rural Health Clinics.



Health Care Workforce Innovation Act

(S. 4957/H.R. 7307 in the 118th Congress)

Sens. Wyden (D-OR) & Blackburn (R-TN); Reps. Molinaro (R-NY) & Craig (D-MN) Scales up promising community-based workforce development programs by authorizing partnerships between Community Health Centers, high schools, community colleges, and Area Health Education Centers to develop preceptorship training-to-practice models for medical, behavioral, and oral health care professionals in integrated community-driven settings.
